Cold War POW, US Marine Corps Major Marvin Carter. was in a plane crash in the desert of Djibouti in the late 1970s. He was captured by rebel forces and held for several months until he was freed by French Foreign Legion Forces stationed in Djibouti. He was a Combat MissionCcommander, providing services and intelligence to multiple government agencies. For years he could not discuss his mission but he now can and we'll be among the first to hear about it.

Today, Dr. Carter runs a veteran nonprofit. He is a recipient of the Joint Services Commendation Medal and the Naval Aviation Observers Device.

Developing citizenship and patriotism

- Developing self-reliance and responsiveness to all authority
- Improving the ability to communicate well both orally and in writing
- Developing an appreciation of the importance of physical fitness
- Increasing a respect for the role of the <u>U.S. Armed Forces</u> in support of national objectives
- Developing a knowledge of team building skills and basic military skills
- Taking 1–3 years of the course grants cadets the ability to rank higher if they pursue a military career.

The SNC MOAA JROTC Awards for this past year have been awarded to Cadets from 26 High Schools in the Las Vegas Area. These Awards were awarded to Cadets in all of programs with the exception of Coast Guard, which does not have a JROTC Program locally; Army, Navy, USMC, Air Force and Space Force programs were present.
